

TERMS AND CONDITIONS:

This promotion is provided by Titan FX Limited and Titan Markets, trading under Titan FX, to its clients. By participating in this promotion, the clients hereby acknowledge, confirm and accept to be bound by the following terms and by Titan FX's Terms and Conditions.

Promotion overview

This Titan FX Winter Giveaway promotion is open to all registered and verified clients of Titan FX who have met the Criteria for this promotion as set out in this Terms and Conditions document to win a prize during the promotion period from December 19th 00:00 GMT+2 to January 9th 23:59 GMT+2. The winners will be announced no later than January 15th.

1. Specific Offer terms

- 1.1. Clients participating in this promotion are offered the chance to win various prizes.
- 1.2. There are 3 (three) levels of prizes in this promotion. To get the opportunity to win a certain level prize, the client has to meet the requirements in the table below.

- 1.3. All asset classes are eligible and count towards achieving the notional trade value requirement.
- 1.4. USD notional trade value is the total value of all the trades opened and closed across the clients accounts. For example, 1 lot of EURUSD is valued at 100,000\$.
- 1.5. A client is eligible to win one prize only, from the highest prize Level that they qualify for.
- 1.6. Only trades that have been both opened and closed in the promotion period of December 19th 00:00 GMT+2 to January 9th 23:59 GMT+2 are eligible trades.
- 1.7. The value of deposits made in all accounts of the client during the promotion period is summed up. Withdrawals exceeding earned profit are subtracted from the total deposit amount. For example, if a client deposits 1,000 USD, earns 500 USD profit, and withdraws 800 USD, his qualifying deposit is calculated as 700 USD instead of 1,000 USD and he is moved to prize Level 2.
- 1.8. The notional value of trades made during the promotion period is summed up. (e.g. if a client opened and closed one 100,000 USD notional value trade, and 100,000 USD notional value during the promotion period, it will be calculated as 200,000 USD notional value traded in total).
- 1.9. The client must register for the promotion by using the link provided in the Titan FX website or email newsletter.

2. Client and account eligibility

- 2.1. The client has to have a registered and verified account.
- 2.2. All live Titan FX accounts are eligible.
- 2.3. Only a cash prize option might be available in some countries. The cash prize is presented as a transfer into the client's Titan FX trading account.

3. Prize Terms

- 3.1. The client will be contacted within 3 working days after the end of the offer period via the specified email and phone number to claim the prize.
- 3.2. It is the client's responsibility to ensure that accurate contact details are provided. If Titan FX is unable to contact the client due to inaccurate contact details provided, and the client does not contact Titan FX within 30 days to claim their prize, the client's prize will be voided without any liability on Titan FX.
- 3.3. Titan FX does not provide invoices and warranty certificates for electronics.

- 3.5. If the client receives a damaged or broken prize, the client must send a photo or video to the customer support of Titan FX. If the damage is confirmed, Titan FX will replace the prize.

4. Delivery terms

- 4.1. The client must choose an address of delivery for the prize. The address must be on the name of the client.
- 4.2. It is the client's responsibility to ensure that an accurate delivery address is provided. The client cannot change the delivery address once the prize has been claimed.
- 4.3. The prize is handed to the client at the address of delivery by courier. If the client is absent for delivery, the courier will handle the re-delivery. The client shall contact the courier to ensure delivery.

5. Fraudulent activity and Withdrawal

- 5.1. Titan FX at its sole discretion can exclude a client from participating in this promotion:
 - 5.1.1. if a client is suspected of fraudulent activity
 - 5.1.2. and/or a client has not acted in good faith
 - 5.1.3. and/or an action by a client is found to be in violation of these terms or Titan FX's Terms and Conditions.
 - 5.1.4. if a client submits false ID documents for the verification procedure.
- 5.2. If the client's withdrawals exceed the profit earned during their eligible period over the promotion window, that withdrawal - net of profit - will be subtracted from the qualifying deposit amount.
- 5.3. The client can withdraw trading profit at any time during the promotion window without decreasing their qualifying deposit amount.

6. General conditions and warranties

- 6.1. In participating in this promotion, you agree to be bound by these terms and Titan FX's Terms and Conditions.
